### ***Constitution***

#### ***组织***

1. The board hereby resolves to establish an Audit Committee of the board to be known as the Audit Committee.  
董事会现议决于董事会辖下成立一个审核委员会。

### ***Membership***

#### ***成员***

2. The members of the Audit Committee shall be appointed by the board from amongst the Non-Executive Directors of the Company and shall consist of not less than three members, a majority of whom should be independent. A quorum shall be two members.  
审核委员会成员须由董事会从本公司的非执行董事中委任。审核委员会最少须由三名成员组成，其中大部分应为独立人士。审核委员会的法定人数为两人。
3. At least one of the members must have appropriate professional qualifications or accounting or related financial management expertise as required under Rule 5.05(2) of the GEM Listing Rules of The Stock Exchange of Hong Kong Limited.  
最少一名委员具备香港联合交易所有限公司创业板上市规则第 5.05(2)条所述之适当的专业资格，或具备适当的会计或相关的财务管理专长。
4. A former partner of the Company's existing auditing firm should be prohibited from acting as a member of the Audit Committee for a period of 1 year commencing on the date of his ceasing (whichever is the later):

  - (a) to be a partner of the firm; or

5. The Chairman of the Audit Committee shall be appointed by the board and should be an independent director.

### *Attendance at meetings*

#### *出席会议*

6. Attendees shall normally include Audit Committee's members, the Finance Director, the Head of Internal Audit (where an internal audit function exists), a representative of the external auditors and those with meaningful input to the Audit Committee's activities. However, at least once a year the Audit Committee shall meet with the external and internal auditors (if any) without executive Board members present.

出席人员一般包括审核委员会成员、财务总监、内部核数部门主管(如公司设有内部核数部门)、外聘核数师的代表及对审核委员会的事宜投入有意义工作的人士。然而,审核委员会应每年最少一次在董事会执行董事避席的情况下,与外聘核数师及内部核数师(如有)举行会议。

7. Members of the Audit Committee may attend meetings of the Audit Committee either in person or through other electronic means of communication.

8. The company secretary shall be the secretary of the Audit Committee. The secretary of the Audit Committee or in his absence, his representative or any one member, shall be the secretary of the meetings of the Audit Committee.

### *Frequency of meetings*

9. Meetings shall be held not less than four times a year. The external auditors may request a meeting if they consider that one is necessary.

会议次数应不少于每年四次。外聘核数师如认为有需要,可要求召开会议。

### *Authority*

10. The Audit Committee is authorized by the board to investigate activity within its terms of reference. It is authorized to seek any information it requires from any employee and all employees are directed to co-operate with any request made by the Audit Committee.

董事会授权审核委员会按照其职权范围进行任何调查。审核委员会有权向任何雇员索取任何所需资料，而所有雇员亦获指示与审核委员会合作，满足其任何要求。

11. The Audit Committee is authorized by the board to obtain outside legal or other independent professional advice and to secure the attendance of outsiders with relevant experience and expertise if it consider this necessary. 董事会授权审核委员会向外咨询法律或其它独立的专业意见；如有需要，可邀请具备相关经验及专业知识的外界人士出席会议。

### *Duties* 职务

12. The duties of the Audit Committee shall be :

- (a) to be primarily responsible for making recommendation to the board on the appointment, reappointment and removal of the external auditor, and to approve the remuneration and terms of engagement of the external auditor, and any questions of resignation or dismissal of that auditor;

- (b) to review and monitor the external auditor's independence and objectivity and the effectiveness of the audit process in accordance with applicable standard. The Audit Committee should discuss with the auditor the nature and scope of the audit and reporting obligations before the audit commences and ensure co-ordination where more than one audit firm is involved;

- (c) to develop and implement policy on the engagement of an external auditor to supply non-audit services. For this purpose, external auditor shall include any entity that is under common control, ownership or management with the audit firm or any entity that a reasonable and informed third party having knowledge of all relevant information would reasonably conclude as part of the audit firm nationally or internationally. The Audit Committee should report to the board,

identifying any matters in respect of which it considers that action or improvement is needed and making recommendations as to the steps to be taken;

In this regard, in reviewing the Company's annual report and accounts, half-year report and, quarterly reports before submission to the board, the Audit Committee should focus particularly on:

- (e) In regard to (d) above :-

- (i) members of the Audit Committee must liaise with the Company's board of directors, senior management and the person appointed as the Company's qualified accountant and the Audit Committee must meet, at least once a year, with the Company's auditors; and

- (f) to review the Company's financial controls, internal controls and risk management systems;

- (g) to discuss with the management the system of internal control and ensure that management has discharged its duty to have an effective internal control system;

- (h) to consider any findings of major investigations of internal control matters as delegated by the board or on its own initiative and management's response;

- (i) to discuss problems and reservations arising from the interim and final audits, and any matters the auditor may wish to discuss (in the absence of management where necessary);

- (j) to review the external auditor's management letter, any material queries raised by the auditor to management in respect of the accounting records, financial accounts or systems of controls and management's response;  
审阅外聘核数师给予管理层的《审核情况说明函件》、核数师就会计纪录、财务账目或监控系统向管理层提出的任何重大疑问及管理层的响应；
- (k) to review the Company's statement on internal control systems (where one is included in the annual report) prior to endorsement by the board;

- (l) where an internal audit function exists to review the internal audit programme, to ensure co-ordination between the internal and external auditors, and to ensure that the internal audit function is adequately resourced and has appropriate standing within the Company, and to review and monitor the effectiveness of the internal audit function;

### ***Reporting responsibility and procedures***

#### ***汇报责任及程序***

13. Where the Board disagrees with the Audit Committee's view on the selection, appointment, resignation or dismissal of the external auditors, the Company should include in the Corporate Governance Report a statement from the Audit Committee explaining its recommendation and also the reason(s) why the Board has taken a different view.

凡董事会不同意审核委员会对甄选、委任、辞任或罢免外聘核数师事宜的意见，公司应在《企业管治报告》中列载审核委员会阐述其建议的声明，以及董事会持不同意见的原因。

14. The secretary or his representative shall circulate the minutes of meetings and reports of the Audit Committee to all members of the Board.

审核委员会秘书或其代表应将审核委员会的会议记录及报告向董事会全体成员传阅。

### ***Publication of the terms of reference of the Audit Committee***

16. The terms of reference of the Audit Committee will be posted on the website of the Company, and will be made available upon request.

### ***Others***

15. The chairman of the Audit Committee or in his absence, another member of the Audit Committee or failing this, his duly appointed delegate, shall attend the annual general meeting of the Company and be prepared to respond to questions at the annual general meeting on the Audit Committee's activities and their responsibilities.
