PERSONAL DATA

Personal Information Collection Statement

The main provisions of the Personal Data (Privacy) Ordinance (Chapter 486 of the Laws of Hong Kong) (the "Ordinance") came into effect in Hong Kong on 20 December 1996. This personal information collection statement informs you of the policies and practices of Zhejiang Yongli and the Company in relation to personal data and the Ordinance.

1. Reasons for the collection of your personal data

To accept the Domestic Share Offer for your Domestic Shares, you must provide the personal data requested. Failure to supply the requested data may result in the processing of your acceptance being rejected or delayed. It is important that you should inform Zhejiang Yongli and/or the Company immediately of any inaccuracies in the data supplied.

2. Purposes

The personal data which you provide on this Green Form of Acceptance and Transfer may be used, held and/or stored (by whatever means) for the following purposes:

- processing your acceptance and verification of compliance with the terms and application procedures set out in this Green Form of Acceptance and Transfer and/or the Composite Document;
- registering transfers of the Domestic Share(s) out of your name(s);
- maintaining or updating the relevant register of holder(s) of the Domestic Share(s) ("Shareholders");
- conducting or assisting to conduct signature verifications, and any other verification or exchange of information;
- distributing communications from Zhejiang Yongli and/or its subsidiaries or agents;
- compiling statistical information and shareholder profiles;
- making disclosures as required by laws, rules or regulations (whether statutory or otherwise);
- disclosing relevant information to facilitate claims on entitlements;

- any other purpose in connection with the business of Zhejiang Yongli; and
- any other incidental or associated purposes relating to the above and any other purpose to which the Shareholders may from time to time agree to or be informed of.

3. Transfer of personal data

The personal data provided in this Green Form of Acceptance and Transfer will be kept confidential but Zhejiang Yongli and/or the Company may, to the extent necessary for achieving the purposes above or any of them, make such enquiries as they consider necessary to confirm the accuracy of the personal data and, in particular, they may disclose, obtain, transfer (whether within or outside Hong Kong) such personal data to, from or with any and all of the following persons and entities:

- Zhejiang Yongli, its subsidiaries and/or agent(s);
- any regulatory or governmental bodies;
- any other persons or institutions with which you have or propose to have dealings, such as bankers, solicitors, accountants, licensed securities dealers or registered institutions in securities; and
- any other persons or institutions whom Zhejiang Yongli and/or the Company considers to be necessary or desirable in the circumstances.

4. Access and correction of personal data

The Ordinance provides you with rights to ascertain whether Zhejiang Yongli and/or the Company hold(s) your personal data, to obtain a copy of that data, and to correct any data that is incorrect. In accordance with the Ordinance, Zhejiang Yongli and the Company have the right to charge a reasonable fee for the processing of any data access request. All requests for access to data or correction of data or for information regarding policies and practices and the kinds of data held should be addressed to Zhejiang Yongli or the Company (as the case may be).
