Constitution

组织

1. The board hereby resolves to establish a Remuneration Committee of the board to be known as the Remuneration Committee.

董事会现议决于董事会辖下成立一个薪酬委员会。

Membership 成员

1. The Remuneration Committee shall be appointed by the board and shall consist of not less than three members, a majority of whom should be independent non-executive directors. A quorum shall be two members, one of whom shall be an independent non-executive Director.

薪酬委员会成员须由董事会委任,其中大部分应为独立非执行董事。薪酬委员会的法定人数为两人,其中一人须为独立非执行董事。

2. The chairman of the Remuneration Committee shall be appointed by the board. 薪酬委员会主席须由董事会委任。

Attendance at meetings 出席会议

1. The company secretary shall be the secretary of the Remuneration Committee. The secretary of the Remuneration Committee or in his absence, his representative or any one member, shall be the secretary of the meetings of the Remuneration Committee.

薪酬委员会秘书为公司秘书。薪酬委员会秘书或其未能出席,其代表或任何一位薪酬委员会会员将出任薪酬委员会会议秘书。

2. Members of the Remuneration Committee may attend meetings of the Remuneration Committee either in person or through other electronic means of communication.

Frequency of meetings 会议次数

1. Meetings shall be held at least once a year. 会议次数应不少于每年一次。

Authority 权力

- 1. The Remuneration Committee is authorised by the board to seek such further information from the management of the Company as it may require in order to enable it to discharge its duties.
 - 董事会授权薪酬委员会按照其职权范围向本公司之管理层索取进一步所需资料。
- The Remuneration Committee should consult the chairman of the board of directors and/or chief executive about their remuneration proposals for other executive directors.

薪酬委员会应就其他执行董事的薪酬建议咨询董事会主席及/或行政总裁。

3. The Remuneration Committee is authorised by the board to obtain outside legal or other independent professional advice and to secure the attendance of outsiders with relevant experience and expertise if it considers this necessary.

Duties 职务

- 1. The duties of the Remuneration Committee shall be: 薪酬委员会的职务如下:
 - (a) to make recommendations to the Board on the Company's policy and structure for all remuneration of directors and senior management^{Note} and on the establishment of a formal and transparent procedure for developing such policy;

- (b) to have the delegated responsibility to determine the specific remuneration packages of all executive directors and senior management^{Note}, including benefits in kind, pension rights and compensation payments, including any compensation payable for loss or termination of their office or appointment, and make recommendations to the board of the remuneration of non-executive directors. The Remuneration Committee shall consider factors such as salaries paid by comparable companies, time commitment and responsibilities of the directors, employment conditions elsewhere in the group and desirability of performance-based remuneration; 获立董事会转授以下职责,即厘订全体执行董事及高级管理人员^注的 特定薪酬待遇,包括非金钱利益、退休金权利及赔偿金额(包括丧失 或终止职务或委任的赔偿),并就非执行董事的薪酬向董事会提出建 议。薪酬委员会应考虑的因素包括同类公司支付的薪酬、董事须付 出的时间及董事职责、集团内其它职位的雇用条件及是否应该按表 现厘订薪酬等:

- (d) to review and approve the compensation payable to executive directors and senior management^{Note} in connection with any loss or termination of their office or appointment to ensure that such compensation is determined in accordance with relevant contractual terms and that such compensation is otherwise fair and not excessive for the Company; 检讨及批准向执行董事及高级管理人员^注支付那些与丧失或终止职务或委任有关的赔偿,以确保该等赔偿按有关合约条款厘定;若未能按有关合约条款厘定,赔偿亦须公平合理,不会对公司造成过重负担;
- (e) to review and approve compensation arrangements relating to dismissal or removal of directors for misconduct to ensure that such arrangements are determined in accordance with relevant contractual terms and that any compensation payment is otherwise reasonable and appropriate; 检讨及批准因董事行为失当而解雇或罢免有关董事所涉及的赔偿安排,以确保该等安排按有关合约条款厘定;若未能按有关合约条款厘定,有关赔偿亦须合理适当;
- (f) to ensure that no director or any of his associates is involved in deciding his own remuneration; and 确保任何董事或其任何联系人不得自行厘订薪酬; 及

(g) to advise shareholders on how to vote with respect to any service contracts of directors that require shareholders' approval under Rule 17.90 of the GEM Listing Rules.

Reporting procedures 汇报程序

1. Draft and final versions of the minutes of the Remuneration Committee meetings shall be sent to all Remuneration Committee members for their comments and records respectively. The secretary or his representative shall circulate the minutes of meetings and reports of the Remuneration Committee to all members of the Board.

Others 其它事项

1.
